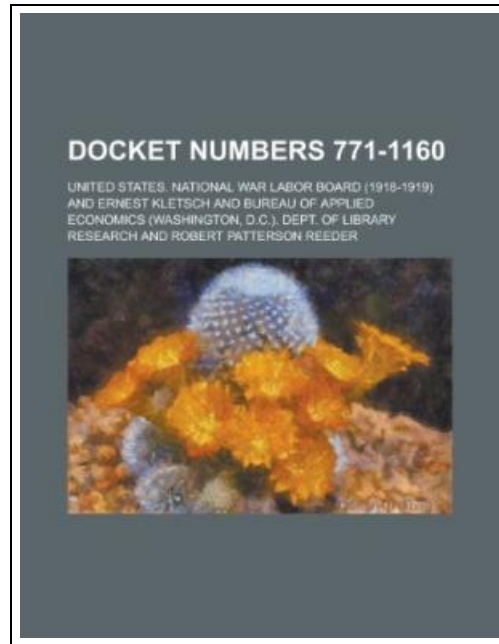

Be it ordered by the National War Labor Board that the following be the award in this case: 1. Hotms. Eight hours shall constitute a day s work for either the day or night shift, to be worked as follows: Day shift, 6.30 a. m. to 3 p. m., allowing onehalf hour for lunch; night shift, 3 p. m. to 11.30 p. m., allowing one-half hour for lunch. 2. OvEnTnaE. That all time worked in excess of the above schedule of hours, in any one day or night, shall be paid for at the rate of time and one-half, except Sundays and holidays, for which double time shall be paid. 3. COLLECTIVE BARGAINING. The right of workers to organize into trade unions and to bargain collectively through their chosen representatives is recognized and affirmed. l ne workers shall have free choice in the selection...
