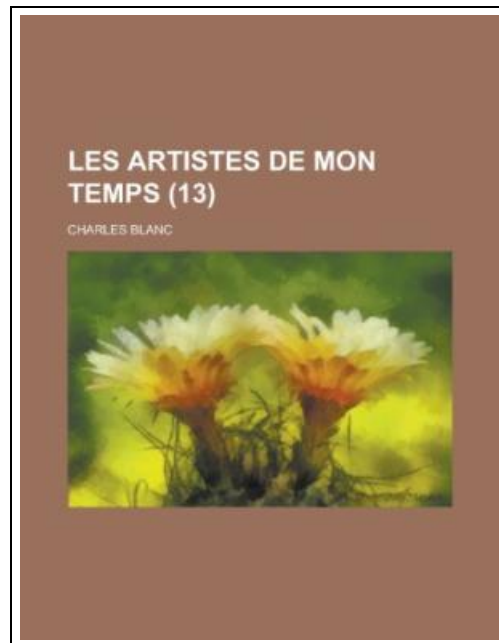

Chapter 9 also states that sponsors preexisting fraud and abuse programs should be focused on controlling fraud by external parties submitting claims to the sponsor, and stated that Part D sponsors are to identify and address internal fraud, waste, and abuse by the sponsor and its employees as well. In chapter 9, CMS also identified examples of potential fraud, waste, and abuse by Part D sponsors, such as marketing schemes to improperly enroll Medicare beneficiaries in Part D plans or deliberately using inaccurate data to receive improper payments from CMS. CMS identified examples of potential fraud, waste, and abuse by Medicare beneficiaries, such as beneficiaries misrepresenting their identity to illegally obtain the drug benefit or engaging in doctor shopping, where a patient seeks prescriptions from multiple physicians with the intent to abuse or sell drugs. CMS identified potential examples of fraud, waste, and abuse by pharmacies, citing improper billing practices, such as billing for nonexistent prescriptions. Regulations and the chapter 9 guidance recognize that contractors can be 19 significantstakeholders in sponsors Part D operations.
