Charitable Deduction for Contributions of Food Inventory Present Law Under present law, a taxpayers deduction for charitable contributions of inventory generally is limited to the taxpayers basis (typically, cost) in the inventory. However, for certain contributions of inventory, C corporations may claim an enhanced deduction equal to the lesser of (1) basis plus one-half of the items appreciated value (i. e. , basis 24 plus one half of fair market value in excess of basis) or (2) two times basis. To be eligible for the enhanced deduction, the contributed property generally must be inventory of the taxpayer, contributed to a charitable organization described in section 501 (c) (3) (except for private nonoperating foundations), and the donee must (1) use the property consistent with the donees exempt purpose solely for the care of the ill, the needy, or infants, (2) not transfer the property in exchange for money, other property, or services, and (3) provide the taxpayer a written statement that the donees use of the property will be consistent with such requirements. In the case of contributed property subject to the Federal Food, Drug, and Cosmetic Act, the property must satisfy the applicable requirements of such Act on the date of transfer and for 180 days prior to the transfer. To use the enhanced deduction, the taxpayer must establish that the fair market value of the donated item exceeds basis. The valuation of food inventory has been...
